IMPORTANT NOTICE REGARDING SOME CHANGES IN ONLINE REGISTRATION PROCEDURE FOR EASE OF APPLICANTS

!!!! ATTENTION ALL PHARMACY APPLICANTS!!!!

(For new registration applications of applicants passing from Maharashtra State which will be received in online system of MSPC on or after 10/10/2018)

Maharashtra state pharmacy council has introduced online registration system for application submission from 7th August 2018 and same was notified in major newspapers .Also notice was displayed on council's website along with flow chart explaining the system.

Till date more than 9000 applicants have submitted their applications by online mode. A review of the procedure was taken in recent Council meeting and communication received from Principal of pharmacy college, verbal communications from some Principals and feedback from MSPC members were collectively discussed and it was resolved to introduce **following changes for online applications which will be received on or after 10th October 2018 (Wednesday) in MSPC online system for ease of applicants** who are aspiring to be Registered Pharmacists of this state.

As per current procedure, Applicant gets his login id and password after following necessary procedure on www.online.mspcindia.org link, enters his/her personal details, qualification details, uploads photo, signature and documents (as per specifications mentioned in manual and guidelines) ***Along with this, additionally now as per new changes applicants are required to download, read and sign an undertaking and then scan and upload same during documents uploading. This will comprise of declaring and accepting that documents uploaded by him /her are true, genuine, belong to applicant himself and not fake or bogus or forged or tampered or fabricated and other set of declaration .Undertaking format is available in “download” section on www.online.mspcindia.org** On successful uploading all documents applicant will make payment of fees through payment gateway.

After this as per previous procedure, applicant used to select appointment date and time slot for verification of original documents at MSPC **.Now as per the new change Applicant is not required take appointment for verification. Thus applicant is exempted from appearing in person and verifying documents in original at MSPC office .**

Though this system will be adopted for ease of applicants in general, in case of certain cases Registrar MSPC can call the applicant in person along with original documents at MSPC and or refer to appropriate authority.

Also **simultaneously** colleges/institutes will be provided login id and password from MSPC. Once application is received in online system of MSPC, first receipt of payment (fees) is confirmed from bank to MSPC and after that application will be processed further for scrutiny by MSPC and from college. Principals or appropriate authority are requested to visit www.online.mspcindia.org and login to MSPC online portal using login id and password provided by MSPC then they will be able to view Name and login id of Applicant who has completed course from their Institute and also view his final year mark list and college leaving certificate or other relevant document

MSPC has already by way of letter requested the respected Principals of the pharmacy institutes (diploma, degree and Pharm D courses) to check and confirm status of applicant as to pass out student of their college and tick in check box as early as possible or latest within seven working days to fasten the processing of application for registration for benefit of applicant. It is expressed in communication from MSPC to colleges to extend co-operation like past and also that NO college will charge for qualification confirmation of said applicant.

At the same time Once scrutiny from both college and MSPC level is done, it will be further processed for approval and granting of registration number .Once registration number is granted, applicant can log in and generate his provisional certificate and use same .Final registration certificate will be processed at MSPC level and sent from MSPC by speed post

All concerned applicants are requested to note the changes which are being introduced for ease of applicants and also refer to flow chart.
